## Expert Witness Testimony

### Impaired Driving

**DUI Training and Experience** includes hundreds of hours of DUI investigation, drug & alcohol, and toxicology training. Formerly certified as an SFST instructor, I-9000 instructor, and DRE instructor, I taught the local police academy's DUI class for nine years, serving as lead instructor for most of that time. Conducted hundreds of investigations, including my cases, assisting less experienced officers, and reconstructing other officers' cases.

**Impairment Identification**, using the three phases of a DUI investigation and the indicia of ingestion and impairment that are observable during those phases. Administering and interpreting basic, standard, and advanced sobriety tests (including horizontal gaze nystagmus) to determine any potential impairment of a subject. Then, investigate the cause of that impairment to determine if it's due to a medical condition or intoxicant ingestion.

**Drug Recognition**, using the signs and symptoms of drug influence (including alcohol) to recognize the drug category, or categories, potentially causing that influence. Plus, adding the observations made during the administration and interpretation of available sobriety tests conducted, followed by an interview with the involved subject, to reach a conclusion.

### Toxicology

**Chemical Testing**, starting with the collection of a valid sample using the minimum standards set for sample collection, to obtain an evidentiary measurement of alcohol or drugs in the human body. For a breath test, the instrument used (i9000) should be properly maintained and operated in accordance with the relevant standards. For blood tests, the collection, transportation, and testing processes have strict minimum standards to ensure accuracy and differ between medical draws and forensic draws.

**Pharmacology**, utilizing knowledge of Pharmacokinetics to understand how intoxicants are processed in the body, enables investigation into potential impairment in a subject. Additionally, using knowledge of pharmacodynamics to assess the potential effects of drugs on the human body, taking into account drug toxicology and drug tolerance.

**Testing Equipment**, a working knowledge of the devices used in breath testing, including both preliminary devices based on fuel cell technology and evidentiary devices based on infrared spectrometry, to determine breath alcohol levels, as well as their strengths and weaknesses in providing such results.

### Vehicle Collisions

**Crash Training and Experience** includes a wealth of on-scene crash investigation experience and classroom or online training in Crash investigation and road safety, including police driver training. Certified as a level one crash investigator. Conducted hundreds of investigations, ranging from minor property crashes to serious injury and fatality crashes, including my own investigations, assisting other officers, and working with the agency traffic unit on reconstructions.

**Roadway Factors**, using the observation of environmental and scene conditions, pre- and post-impact markings on the road surface, and property damage to determine the events of the crash scenario. Including skid marks or other evidence to estimate reaction times and vehicle speeds.

**Vehicle Factors**, using the internal and external observations of involved vehicles, including operational condition, damage sustained, and substance transfer or markings. Additionally, video recordings or other digital evidence available from the vehicle can reveal the events leading up to the crash.

**Human Factors**, including any bodily injuries, victim placement and strike points, driver and passenger statements, independent witness statements, witness viewpoints, and any digital recordings available to help determine the proximate cause of the crash.

### Traffic Contacts

**Traffic Training and Experience** include training at the police academy and during field training to conduct traffic stops safely and to understand the reasons for the stop. A POST-certified police officer who worked primarily on patrol with a focus on traffic safety and enforcement. I have conducted hundreds of traffic stops per year during my career. Assisting other officers from my own and other agencies with their traffic stops.

**The Colorado Traffic Code** utilizes both state and municipal statutes to enforce moving, equipment, and administrative traffic violations, as well as conduct legal traffic stops for various purposes, including traffic enforcement, suspicious activity, drug interdiction, and high-risk stops.

**Police Process**, using training and experience to understand how officers are taught to conduct traffic stops safely, from the initial violation through stop location prediction, approach to the vehicle, and conducting business at the vehicle. Including what indicators and behaviors to look for in a legal authority with occupants of the vehicle.

Depending on the case and testimony required, the endorsements tend to include the following:

- Expert in DUI investigations, identification of impaired drivers, the administration and interpretation of SFST & ARIDE sobriety tests, the DRE/DECP Evaluation Protocol, and the effects of drugs on the human body.
- Expert in traffic enforcement, the operation of radar & lidar units, visual speed estimation, traffic crash investigations, including property damage and injury crashes
- Expert in the collection of evidentiary toxicological samples, including preliminary breath tests, forensic and medical blood draws, and the operation and function of breath testing instruments such as the CMI I9000.
